CALL FOR HALL GRANT PROPOSALS DEADLINE: OCTOBER 15, 2020

The late Dr. Tom Hall, a global health leader was one of CUGH's greatest advocates. He passed away May 20, 2017, but his legacy of giving lives on. In his will he generously provided a gift to support small global health education grants. CUGH members are invited to apply for a Dr. Tom Hall Education Grant (each are under \$5,000). 10 grants will be offered this year. Projects should improve education outcomes, advance knowledge, or address the implementation and scaling up of an initiative that improves human and environmental outcomes. Preference will be given to applications that address the intersection of human wellbeing, demographic changes and environmental sustainability.

Eligible areas of interest for grant support include but are not limited to:

- The development of educational materials and/or programs that improve human health and environmental health.
- Initiatives that address planetary sustainability, protecting ecosystem services or One-Health.
- Capacity building in a in Low- or Middle-income country.
- Promote, develop and/or disseminate clinical and community case studies
- Special education-related events at the annual CUGH conference
- Identify and aggregate good practices, useful courses, teaching material, reports, and guidelines in global health with the aforementioned areas of focus for open access sharing on CUGH's website
- CUGH Trainee Advisory Committee activities and projects

Criteria for Grant Approval

- Consistent with the mission of CUGH (CUGH supports academic institutions and partners to improve the wellbeing of people and the planet through education, research, service, and advocacy)
- Consistent with the objectives of the grant to promote and facilitate global health education, education products that impact the environment, and human wellbeing
- Project impact and efficiency is optimized
- High quality proposal with the potential for translation and scaling up
- The lead Principal Investigator of a grant application must be a member of CUGH via an institution or individual affiliation
- Grant funds shall not be used to pay or supplement salaries of the project leader. However, shortterm NON-FACULTY staff support to implement approved projects involving data collection, analysis, etc., can be covered
- 50% of an approved grant will be disbursed at the start of the project and the balance will be disbursed on project completion and submission of a brief report of the project's accomplishments to CUGH's Secretariat

Criteria for Evaluating Grants- See the 10-point criteria and point system below.

Additional notes when preparing your application:

- ***Institutional overhead costs are not allowable costs in these grants.
- ***Successful applicants will be responsible for any taxation associated with the grant.

HALL GRANT PROPOSAL SELECTION REVIEWER SCORING

This checklist serves as a guide for Reviewers of the Hall Grant Proposal submissions. Up to 10 grants will be offered this year, each up to \$5,000 USD. The projects should be completed within 1 year. Reviewers should consider educational projects that advance knowledge, implementation, and impact. Applications should include a Grant Application Form, budget, project narrative as well as appendices which may include supporting documents such as log frames, GANTT chart, or project oversight documents. Grant funds may not be used to pay or supplement salaries of the project leader.

Please score applications based on the following criteria. If an application poses a potential opportunity for bias, please inform the Deputy Director.

Evaluation for each proposal has been divided into the following 10 categories. Criteria are listed for each category and may be scored up to a listed maximum. The overall maximum total is 100 points:

- 1. Project title and description congruent with CUGH's mission (10 pts)
- 2. Scope of the project (20 pts)
- 3. Addresses demographics and sustainability (10 pts)
- 4. Impact and significance (10 pts)
- 5. Methodology (10 pts)
- 6. Evaluation plan (5 pts)
- 7. Management plan and team qualifications (10 pts)
- 8. Dissemination plan (5 pts)
- 9. Budget justification (10 pts)
- 10. Format (10 pts)

Overall comments may be provided upon completion of the application review to provide context of the scoring and evaluation.
