How do I see if my institution is a member?

You can view all member institutions on our website.

How does CUGH know I am a member?

If the institution or organization of your email domain is an Institutional member, you are a member.

Am I a member if another department in my Institution is a member?

Yes, once one department in an institution/university/organization is a member, all students, faculty and staff in the entire institution/university/organization are members as well.

How are CUGH membership fees determined?

To make global health more equitable, member fees and conference rates are a sliding scale based on the World Bank's Classification (HIC/MIC/LMIC/LIC)

What fields of study qualify as "global health?"

We want to work with anyone who feels their work aligns with global health or development. Our members are MDs, PhDs, DrpHs, dentists, nurses, engineers, lawyers, veterinarians, social scientists, public policy experts, economists, finance experts etc. Our network includes individuals across sectors: academia, NGOs, INGOs, government, the private sector engaged in international development, politics, the environment, finance, human rights etc.

Can non-academic institutions join CUGH?

CUGH accepts members both from academic and non-academic organizations (e.g. INGOs, Associations, Foundations, UN agencies, NGOs, the private sector, government). Organizations must be registered in the country of origin.

How many countries are involved in CUGH?
