MISSION

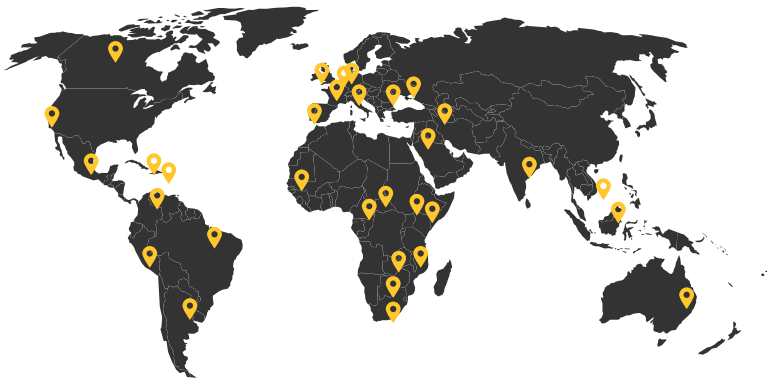
We address health-related disparities and inequalities by:
